UMN Medical Laboratory Sciences Celebrates 100th Anniversary

In 1922, the University of Minnesota began offering courses in medical laboratory at that time known as medical technology. One hundred years later, it has become the oldest MLS baccalaureate degree granting program in the United States. Because the first graduating class occurred in 1923, the UMN program is making this a year-long celebration. The kick-off event was held at the Alumni Banquet this past April at the McNamara Alumni Center. The Program was delighted that former Program Directors Drs. Karen Karni and Dr. Janice Conway-Klaassen were able to attend.

2022 Legislative Symposium

On September 26, nearly 120 medical laboratory professionals from six organizations joined together in Alexandria, Virginia, and virtually for the 2022 Laboratory Legislative Symposium. Members from ASCLS, the American Society for Clinical Pathology (ASCP), Association of Genetic Technologists (AGT), American Medical Technologists (AMT), National Society for Histotechnology (NSH), and the Philippine Association of Medical Technologists-USA (PAMET-USA) learned about the legislative issues impacting medical laboratories and how “Labvocates” can make their voices heard on Capitol Hill. The audience learned tips and tricks for successfully interacting with members of congress including practical application through role play practice. Props to the brave souls who volunteered to role play in front of the group!

The presenters included Jim Flanigan (EVP-ASCLS) and Patrick Cooney (President -The Federal Group, Inc.) as well as speakers from Lab Workforce Steering Committee, NILA, ASCP, ACLA, and other invited guests.

The main topics included:

- Washington Updates
- Levers of influence with congress
- Saving Access to Laboratory Services Act (SALSA)

- Nomenclature standardization - Medical Laboratory Scientist (MLS) – “I am MLS” Challenge

2022 Legislative Symposium, continued



The levers of influence within government and advocacy can be described as a three-legged stool: 1) coalition building, 2) grassroots action, and 3) shoe leather lobbying. The audience was encouraged to get to know their local legislators and to recognize that they are not out of reach – legislators want to talk to their constituents.

We are at the tail end of the 117th congress (2021-2022). Elections will be held this fall and then a new congress will begin in January 2023. A total of 470 seats in the U.S. Congress (35 of 100 Senate seats and all 435 House seats) are up for election on November 8. There will be a “Lame Duck” session (comprised of outgoing elected officials whose successors have already been elected or will be soon) after November elections, which may be the best opportunity to complete work on various lab related policy items. Patrick Cooney stated that we were in DC at a great time!

Cooney went on to say that this is a difficult time for bipartisan efforts – hearings on the Jan 6th insurrection, Supreme Court rulings are dividing the nation, the conflict in Ukraine, and mid-term elections in November. But even in this environment, many bipartisan efforts are happening. Our lab issues are, indeed, bipartisan.

Federal Lab issues include:

- Medicare Part B Lab Fee Schedule
- VALID act and LDTs
- Lab Workforce Shortages
- Supply Chain Concerns
- Prior Authorization reform for Medicare Advantage Plans

Saving Access to Laboratory Services Act (SALSA)

On June 22, 2022, legislation was introduced in Congress to update the laboratory reimbursement reporting requirements under the Protecting Access to Medicare Act (PAMA); The Saving Access to Laboratory Services Act (SALSA) (S.4449/H.R.8188). SALSA would require the Centers for Medicare and Medicaid Services (CMS) to use a statistically representative sample of rates from the laboratory market to determine Medicare's Clinical Laboratory Fee Schedule (CLFS) and would increase the time between reporting periods from three to four years. The call to action when visiting Capitol Hill was to ask Congress to show support for the laboratory community and Medicare patients by cosponsoring SALSA and to urge House and Senate leaders to take up SALSA before the end of the year as part of broader Medicare legislation.

Clinical Laboratory Workforce

BIO Preparedness Workforce Act (H.R.5602/S.1018, introduced by Rep. Trahan (D-MA) and Senator Tammy Baldwin (D-WI) - This bill makes clinical laboratory technologists and technicians eligible for student loan repayment in exchange for up to 3 years of service in an underserved area in relation to bio preparedness and infectious disease. Components of this Act are included in the Prepare for and Respond to Existing Viruses, Emerging New Threats, and Pandemics Act” or the “PREVENT Pandemics Act” (S.3799). This bill was marked up in March of 2022 but has not seen further action.

2022 Legislative Symposium, continued

Medical Laboratory Personnel Shortage Relief Act

This bill would create a grant program to assist schools of allied health to recruit necessary faculty and provide clinical training necessary to enter the profession. The bill would also provide loan repayment for clinical laboratory professionals in exchange for service in medically underserved communities.

The call to action when visiting the Hill was to ask Congress to:

1. Establish a program of scholarships and loan repayment, similar but distinct from the National Health Service Corp, to alleviate the shortage of clinical laboratory personnel.
2. Establish a federal grant program to assist allied health schools in recruiting and retaining clinical laboratory students to improve the availability of these professionals throughout the U.S.

CMS Proposed Rule for CLIA Nursing and Lab Testing

This topic was discussed but did not have a call to action for Capitol Hill visits. CMS is collecting and considering comments from the industry (approximately 20,000 comments have been sent). Both laboratory and nursing advocacy groups are weighing in on this topic. Also, to be determined is whether a Doctorate in Clinical Laboratory Science (DCLS) is adequate for a director of a high complexity testing.

Member Spotlight

My name is Rachel Siddall and I am both honored and excited to be the Southeast Area Region Director this year!

My laboratory career started at Ferris State University in Big Rapids, MI where I received my MLS degree. I interned at the University of Michigan and worked in their microbiology lab after graduation. I spent a summer during undergrad as a student in a Mayo Clinic laboratory and knew I wanted to move to Rochester. I currently work in Bacteriology at the Mayo Clinic and am working on my Doctorate of Clinical Laboratory Science (DCLS) at Rutgers University.

My first role in ASCLS was as Developing Professional Director where I attended the annual meeting in Louisville, KY and lead the Developing Professional Forum. This is my second year as a region director for ASCLS-MN.
